

Meeting of the Governing Council MIB Trieste Alumni Association February 21st, 2022 – 7:30-8:30 pm

The main topics discussed during the meeting are reported below

1. Approval of the MoM of the last Board

The Governing Council (GC) approved the MoM of the Board held on January 18th.

2. Reunion 2022: confirmation date and planning of the activities

Saturday, September 10^{th,} was confirmed by the School as data of the Reunion 2022.

3. Barcolana 2022 / Other events

Politecnico di Milano School of Management (MIP) has organized a regatta planned for half-May open to Business School (presentation provided to the Board by Gonzalo) proposing the participation to MIB School of Management. The Association will manage the official communication and marketing. The School would allocate no economic support/budget. Initial costs: 650/750 euro per person. The Organization provides the boat, and the price includes the rental of the ship, the meals, and the accommodation of the participants for 2 days. The Board agreed on the Networking opportunity to be offered to the Community.

⇒ The Board will inform and sponsor the regatta to the Alumni

However, the School confirmed the Barcolana 2022. The Board will manage the involvement of the MIP to the Barcolana, in case of the official confirmation from the School, to foster the Networking and visibility.

4. Ambassadors' involvement to the Board initiatives and Reunion

The Board is willing to involve a number of Ambassadors – based on their active contribution to the activities underpinned by the Board during the past year – in the planning and execution of the 2022 activities, by inviting them to the next Board meeting to be held in March.

The Board is also open to invite 2/3 ambassadors per meeting to participate and contribute to the discussions in the next months.

5. Special Programs & Communication updates

Irma updated on the volunteering days to align on the strategy to pursue. The official logo was also presented to the Board and the second layout was approved.
